Harlem Avenue, Suite A, Worth, Cook County, Illinois, who affirmatively represented himself as the cuthorized agent of the Owner (the "Owner's Agent") to furnish material and labor for demolition, excavation, construction, masonry, paving, curbs, sidewalks, stucco, drywall, glazing, concrete, rooming electrical, plumbing, H.V.A.C., alarms, light poles, sprinklers, insulation, gutters, storm and sanitary sewers for the sum of \$513,049.00. The Lien Claimants and Owner's Agent subsequently agree I that the Lien Claimants would furnish additional material and labor for extras for environmental remediation and other changes for the sum of \$254,513.67.

That on April 3, 2007, the Lien Claimants completed all work required pursuant to the original contract and subsequent change orders.
