The receiver issued a certificate in the amount of \$22,588.46 and bearing interest at 9% annum for cost and fees, which was transferred to the City of Chicago.

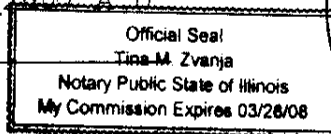
