As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from or raight be characterized as) a portion of Borrower's payments for Mortgage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." THIS FIXED/ADJUSTABLE RATE RIDER is made this 20th day of JUNE , 2007 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, c. Security Deed (the "Security Instrument") of the same date given by the undersigned ("Borrower") to secure Borrower's Fixed/Adjustable Rate Note (the "Note") to BANCO PCPULAR NORTH AMERICA

THE NOTE PROVIDES FOR A CHANGE IN BORROWER'S FIXED INTEREST RATE TO AN ADJUSTABLE INTEREST RATE. THE NOTE LIMITS THE AMOUNT BORROWER'S ADJUSTABLE INTEREST RATE CAN CHALGE AT ANY ONE TIME AND THE MAXIMUM RATE BORROWER MUST PAY.
