THIS MORTGAGE ("Sec crity Instrument") is given on June 23, 2007. The mortgagor is Mary Thomas, A Widow, whose address is 10914 S. Walfash Ave., Chicago, Illinois 60628 ("Borrower"). - 11. Reinstatement. Borrower has a right to be reinstated if Lender has required immediate payment in full. This right applies even after foreclosure proceedings are instituted. To reinstate this Security Instrument, Borrower shall correct the condition which resulted in the requirement for introdiate payment in full. Foreclosure costs and reasonable and customary attorneys' fees and expenses properly associated with a foreclosure proceeding shall be added to the principal balance. 12. First Lien Status

- 22. Adjustable Rate Feature. The Calculated Interest Rate will be adjusted if necessary to comply with the rate limitation(s) described above and will be in effect until the next Change Date. At any change date, if the Calculated Interest Rate equals the Existing Interest Rate, the interest rate will not change.
