## AND AMENDMENT OF LEASE

THIS LEASE AMENDMENT dated as of the \_q day of \_\_\_\_\_\_\_, 2007, by and between the PUBLIC BUILDING COMMISSION OF CHICAGO, a municipal corporation with offices located at Richard J. Daley Center, 66 West Washington Street, Suite 200, Chicago, Thinois 60602 (hereinafter referred to as the "Commission"), and the BOARD OF EDUCATION OF THE CITY OF CHICAGO, a municipal corporation with offices located at 125 South Clark Street, Chicago, Illinois 60603 (hereinafter referred to as the "Board"):

WHEREAS, by Quit Claim Deed dated June 17, 1996 and recorded by the Recorder of Deeds of Cook County, Illinois, as Document No. 96494973, the "Deed"), the City of Chicago, in Trust for the Use of Schools (the "City"), on behalf of the Board, conveyed the property commonly known as Wadsworth CPC School and located at 6407 S. Blackstone Avenue, Chicago, Illinois 60637, and legally described on Exhibit A hereof (the "Property") to the Commission subject to reverter of the Property to the City in trust for the use of Schools at such time as all principal, interest and premium, and all other expenses of the Commission with respect to the Commission's Building Revenue Bonds, Series "A" of 1993 (to a "Bonds") shall have been paid in full; and

WHEREAS, PBC and the Board entered into Amendment No. 1 to Lease Agreement dated as of June 14, 1996 and recorded by the Recorder of Deeds as Document No. 94090067 (the "Lease"), pursuant to which the Property was leased to the Board subject to the terms of the Lease Agreement dated as of April 1, 1993 (the "Original Lease"); and

WHEREAS, the Original Lease provides that title to the Leased Sites shall be reconveyed to the City in trust for the Board at such time as all principal, interest and expenses

of the Commission with respect to the Bonds have been paid in full; and

WHEREAS, the Board has requested by Resolution No. 06-0222-OP5 adopted February 22, 2006, that the Commission convey the Property to the City of Chicago (the "Grantee"); and

WHEREAS, pursuant to Resolution No. 7028 adopted by the Board of Commissioners of the Commission on March 13, 2007, the Commission has approved the request of the Board to convey the Property to the Grantee and authorized the transfer of title to such property to the Grantee;

#### NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. The Board hereby disclaims any reversionary interest that it may have in and to the Property and, notwithstanding the provisions in the Deed and the Lease to the contrary, agrees that the Property as legally described on Exhibit A shall not be reconveyed to the City in trust for the Board at such time as the principal, in erest and premium on the Bonds, and all other administrative expenses of the Commission and all other accrued and unpaid expenses with respect to the Bonds have been paid in full.
- 2. The Board and the Commission hereby agree that the Lease by and between the parties is hereby amended to delete the property described in Exhibit A from the schedule of parcels described in the Lease as the Leased Premises:
- 3. With the exception of the foregoing disclaimer of interest by the Board and the deletion of the property described in Exhibit A from the Leased Premises as described in the original Lease, all other provisions of the original Lease shall remain in full force and effect.
