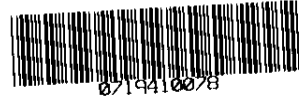

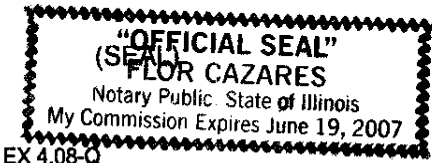

LEGAL DESCRIPTION

FLAHERTY'S SUBDIVISION OF THE EAST 1/2 AND THE EAST 1/2 OF THE WEST 1/2 OF THE NORTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 20, TOWNSHIP 36 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS. EXCEPT THAT PART OF LOTS 7 TO 11, INCLUSIVE, IN BLOCK 2 IN HARVEY HIGHLANDS, BEING A RESUBDIVISION OF M. FLAHERTY'S SUBDIVISION OF THE EAST HALF AND THE EAST HALF OF THE WEST HALF OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 20, TOWNSHIP 36 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF SAID LOT 11; THENCE ON AN ASSUMED BEARING OF NORTH 89 DEGREES 18 MINUTES 52 SECONDS EAST ALONG THE NORTH LINE OF SAID LOTS 7 THROUGH 11, INCLUSIVE, A DISTANCE OF 37.111 METERS (121.76 FEET) TO THE NORTHEAST CORNER OF SAID LOT 7; THENCE SOUTH 29 DEGREES 33 MINUTES 30 SECONDS EAST ALONG THE EAST LINE OF SAID LOT 7 A DISTANCE OF 3.353 METERS (11 FEET); THENCE SOUTH 89 DEGREES 18 MINUTES 52 SECONDS WEST 33.170 METERS (108.82 FEET); THENCE SOUTH 66 DEGREES 50 MINUTES 46 SECONDS WEST 4.269 METERS (14.00 FEET) TO THE WEST LINE 4.984 METERS (16.53 FEET) TO THE POINT OF BEGINNING. SAID PARCEL CONTAINING 0.0123 HECTARES (0.032 ACRES), MORE OR LESS. SITUATED IN THE COUNTY OF COOK, AND IN THE STATE OF ILLINOIS.
