VOLUNTARY ARBITRATION RIDER

THIS RIDER is made this 25th day of June, 2007, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note (the "Note") to SAXON MORTGAGE, INC.
