- A. ADDITIONAL PROPERTY SUBJECT TO THE SECURITY INSTRUMENT. THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY CAR TIME AND THE MAXIMUM RATE THE BORROWER MUST PAY.

The Note provides for an initial interest rate of 9.700 %. The Note provides for changes in

then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal
that I am expected to owe at the Change Date in full on the Matu ity Date at my new interest rate in
substantially equal payments. The result of this calculation will be the new amount of my monthly
payment. The interest rate I am required to pay at the first Change Date will not be greater than 12.700 % or less than 6.700 %. Thereafter, my interest rate will never be increased or
decreased on any single Change Date by more than 1.000 % from the rate of interest I have been
