WHEREAS, Kathleen S. Kenefick and John W. Kenefick request the right to the exclusive use of the limited common elements appurtenant to each unit.

NOW, THEREFORE, the Declaration is hereby amended as follows:

- 1. Kathleen S. Kenefick and John W. Kenefick's written request to combine unit numbers 1003 and 1004 at the Association is granted.
- 2. Kathleen S. Kenefick and John W. Kenefick will undertake the responsibility to pay assessments for Unit 1003, as well as Unit 1004, as required by the Association's Declaration.
- 3. The two combined units will be known as Unit 1003 as of the effective date of this amendment, and the percentage of ownership for the combined unit will be 1.89%.
- 4. Kathleen S. Kenefick and John W. Kenefick are granted the exclusive use of the limited common elements appurtenant to the new unit number 1003, as being comprised of all limited common elements previously appurtenant to units 1003 and 1004.
- 5. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 6. Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
