- 1. Definition of Lender. Lender is now Cathay Bank, a California Banking Corp., successor interest by merger to New Asia Bank
- 2. Definition of Note. The word "Note" means the Promissory Note dated June 15, 2006 in the principal amount of \$750,000.00 from Borrower to Lender as modified by a Change In Terms Agreement of even date herewith, together with any and all renewals, extensions, modifications and replacements thereof. NOTICE TO GRANTOR: THE NOTE CONTAINS A VARIABLE INTEREST RATE.

This waiver applies not only to any initial extension or modification, but also to all such subsequent accords.
