- 6. Protection of Our Rights in the Property; Mortgage Insurance. CONDOMINIUM RIDER

THIS CONDOMINIUM RIDER is made this 2nd day of July, 2007 and is incorporated into and shall be deemed to amend and supplement the HELOC Mortgage, HELOC Deed of trust Open-End Mortgage, Open-End Deed of Trust, HELOC Security Deed, Deed of Trust, Home Equity Deed of Trust, Credit Line Mortgage, Line of Credit Trust Deed, HELOC Open-End Mortgage, Credit Line Deed of Trust, Multiple Indebtness Mortgage, Mortgage-Short-Term Mortgage Redemption, Mortgage-One Hundred Eighty Day Redemption Mortgage-Collateral Real Estate Mortgage (the "Security Instrument") of the same date given by the undersigned to secure the undersigned's Agreement referred to in the Security Instrument.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as:Lakewood Condominium Assosiation

(the "Condominium Project")

If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit of use of its members or shareholders, the Property also includes your interest in the Owners Association and the uses, proceeds and benefits of your interest.

CONDOMINIUM COVENANCS. In addition to the covenants and agreements made in the Security Instrument, you and we further covenant and parce as follows:

- A. Condominium Obligations. You shall perform all of your obligations under the Condominium Project's Constituent Documents. What we require as a condition of this waiver can change during the term of the loan.

You shall give us prompt notice of any lapse in required hazard insurance coverage provided by the master or blanket policy.

In the event of a distribution of hazard insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to you are hereby assigned and shall be paid to us for application to the sums secured by the Security Instrument, whether or not then due, with the excess, if any, paid to you.

- C. Public Liability Insurance. You shall take such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount, and extent of coverage to us.

You shall not, except after notice to us and with our prior written consent, either partition or subdivide the Property or consent to: (I) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of a taking by condemnation or eminent domain; (ii) any amendment to any provision of the Constituent Documents if the provision is for the express benefit of us; (iii) termination of professional management and assumption of self-management of the Owners Association; or (iv) any action which would have the effect of rendering the public liability insurance coverage maintained by the Owners Association unacceptable to us.

F. Remedies. If you do not pay condominium dues and assessments when due, then we may pay them. Any amounts disbursed by us under this paragraph F shall become an additional debt secured by the Security Instrument. Unless you and we agree to other terms of payment, these amounts shall bear interest from the date of disbursement at the rate of interest specified in the Agreement and shall be payable, with interest, upon notice from us to you requesting payment.
