- 3) Respondent is granted leave to file a Motion to Reconsider today's court order.

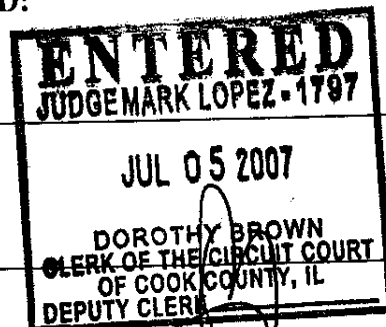
