5. Property Insurance. Sorrower shall keep the improvements now existing or hereafter erected on the Property insured against icus by fire, hazards included within the term "extended coverage," and any other hazards including, but not lirtuid to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. The 30-day period will begin when the rotice is given.
