

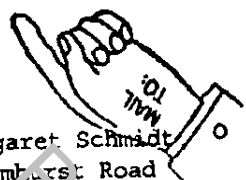

## MORTGAGE
