Alternatively, the Owner knowingly permitted Nong to enter into contracts for the improvement of the Real Estate.
- 4. Claimant last performed work under the subcontract with Nong to the project site at 33+1-2343 North Clark Street, Chicago, Illinois on April 10, 2007.
- 5. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for paymen's by Nong, the balance of \$50,100.00 for which, with interest, Claimant claims a lien on the Real Estate.
