That on **May 22, 2007**, the owners of the above described property were notified in writing in accordance with the above mentioned ordinance provisions, but that said owners neglected and/or refused to cut the weeds.

That on **June 8, 2007**, the Village of Hanover Park, Illinois caused said weeds to be cut, removed, and destroyed and the reasonable cost and expense incurred for the work was **\$150.00**, and that said sum remains unpaid.

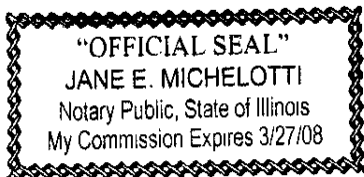
