## MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated July 17, 2007, is made and executed between AmeriMark Bank, not personally but as Trustee on behalf of AmeriMark Bank Trust #01-522 dated August 1, 2001, whose address is 5456 S. 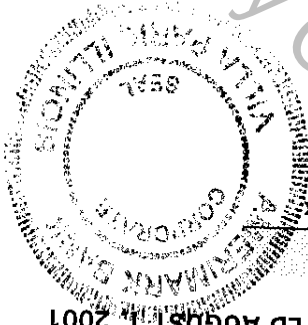

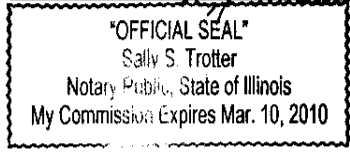
