He further certifies that he estimated what proportion of the total cost of such improvement would be of benefit to the public and what proportion thereof would be of benefit to the property to be benefitted, and apportioned the same between the Village of Brookfield and such property so that each will bear its relative equitable proportion and are just and equitable; the amount so estimated and apportioned to the Village of Brookfield as public benefit being \$59,120.00, and the amount so estimated and apportioned to the property to be benefitted being the sum of \$201,680.00 and having found such amounts the undersigned did apportion and assess the amount so found to be of benefit to the property upon the several lost, blocks, tracts and parcels of land in the proportion in which they will severally be benefitted by such improvement; and that no lot, block, tract or parcel of land has been assessed a greater amount than it will be actually benefitted.
