Mortgagor covenants and agrees:

- 1. To pay, when due, all sums secured hereby.
- 2. Not to abandon the premises; to keep the premises in good condition and repair and not to commit or suffer waste; to pay for and complete within a reasonable time any building or improvement at any time in the process of erection upon the premises; to promptly repair, restore, or promptly repair, restore, or rebuild any building or improvement now or hereafter on the premises; to which may become damaged or destroyed; to refrain from impairing or diminishing the value of the security; to make no material alterations of the premises.
- 3. To comply with all requirements of law or municipal ordinances governing the premises and the use thereof; and to permit Mortgagee to inspect the premises at all reasonable times.
