MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated July 5, 2007, is made and executed between Chicago Title Land Trust Company Successor Trustee to Fifth Third Bank, Successor Trustee to Old Kent Bank, Successor Trustee to Pinnacle Bank, Successor Trustee to First National Bank of Cicero as Trustee U/T/A dated July 17, 1980 and known as Trust No. 6783, whose address is 6316 North Northwest Highway, Chicago, IL 60631 (referred to below as "Grantor") and First Bank, whose address is 2100 South Elmhurst Road, Mount Prospect, IL 60056 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated January 8, 1996 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.



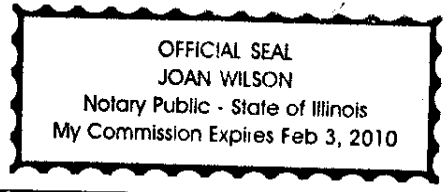
