THIS AGREEMENT is made and entered into this <u>07/12/2007</u>, by and between Citibank, N.A., whose place of business is 3900 Paradise Road, Suite 127, Las Vegas, NV 89109 (tie 'Londer"), and <u>YEVGENIY BOLOTNIKOV</u>, (collectively referred to herein as "Borrower"). - 1. **CREDIT LIMIT INCREASE.** Borrower and Lender hereby agree to increase the Credit Limit set forth in the Note to \$190,000.00 and to modify the Security Instrument so that the principal amount secured by the Security Instrument is \$190,000.00.

- 3. **SECURITY INSTRUMENT.** Lender and Borrower agree that the Security Instrument described above will continue to secure all obligations to Lender under the Note as modified by this Agreement. Nothing in this Agreement will affect or impair Lender's security interest in, or lien priority on, the property described in the Security Instrument, and/or be construed to be a novation, satisfaction or a partial or total release of the Note or Security Instrument.
