

#### Exhibit B

#### **Permitted Exceptions**

- 1. Real estate taxes not yet due and payable;
- 2. Special taxes or assessments for improvements not yet completed and other assessments or installments thereof not due and payable at the time of Closing.
- 3. Applicable zoning, planned unit development and building laws and ordinances;
- 4. Encroachments, utility easements, covenants, conditions, restrictions, easements, and correments of record, providing none of the foregoing materially adversely affect Buy er's quiet use and enjoyment of the property as a residence.
- 5. The Declaration of Easements, Restrictions and Covenants for Bradley Place II Homeowners Association and all amendments and exhibits thereto;
- 6. That certain notice regarding the use of properties adjoining the Development recorded in the Office of the Recorder of Deeds of Cook County, Illinois.
- 7. The covenants contained in the following paragraph:

"Bradley Place II Homeowners Association, Grantor, Grantee and their prospective heirs, successors and assigns (collectively, the "Obligated Parties") are hereby prohibited from taking any actions to restrict the operations of the real estate to the north of the Development (the "Benefitted Property") currently owned and/or used by Tribune Company and/or any of its affiliates and/or subsidiary companies, including, without limitation, the WGN broadcasting companies, provided such operations are in compliance with applicable health and salety laws, statutes, ordinances, governmental rules and regulations and judicial rulings. The Colligated parties are further required to maintain landscaping on the Development so as not to interfere with satellite transmissions received at or transmitted from the Banefitted Property."

- 8. Acts done or suffered by Buyer, or anyone claiming, by, through, or under Buyer;
- 9. Buyer's mortgage, trust deed, or other security documents; and
- 10. Liens and other matters as to which the Title Insurer commits to insure Buyer against loss or damage (collectively, the "Permitted Exceptions").
