FIRST AMENDMENT TO I/ECLARATION OF EASEMENTS, COVENANTS AND RESTRICTIONS FOR THE TOWNHOMES AT EASTGATE VILLAGE TOWNHOUSE ASSOCIATION: ANNEXATION AMENDMENT (PHASE I-BUILDING 5 & BUILDING 4 TOWNHOUSE)

This First Amendment is made and entered into this the day of August, 2007, by EASTGATE VILLAGE ONE, L.L.C., an Illinois limited liability commany (hereinafter referred to as "Declarant").

WITNESSETH:

WHEREAS, by a Declaration of Easements, Covenants and Restrictions for the Townhomes at Eastgate Village Townhouse Association (the "Declaration") recorded in the Office of the Recorder of Deeds of Cook County, as Document No. 0719715113, Declarant submitted certain real estate to the provisions of the Declaration.

WHEREAS, the Declaration reserves to Declarant the right to annex and add to the Property (as defined in the Declaration), and thereby add and subject to the terms, covenants, easements and restrictions (the "Provisions") created by the Declaration, all or any portion of the Additional Property (as defined in the Declaration).

WHEREAS, Declarant now desires to so annex and add the portion of the Additional Property known as Building 5 and containing five (5) townhomes (the "Phase I Building 5 Parcel") and the portion of Building 4 containing one (1) townhouse (the "Phase I Building 4

Townhouse Parcel"), all as legally described in Exhibit "A-2" attached hereto (the "First Additional Property").

WHEREAS, EASTGATE VILLAGE ONE, L.L.C. is the owner of the First Additional Property, and desires to make the First Additional Property subject to the Provisions of the Declaration and this First Amendment, and to make the First Additional Property a part of the Property.

NOW, THEREFORE, the Declarant hereby amends the Declaration as follows:

- 1. Exhibit "A" of the Declaration is hereby amended by adding thereto the First Additional Property. The amended legal description of the Property including the First Additional Property is attached hereto as Exhibit "A". The First Additional Property, legally described in Exhibit "A-2" attached hereto and incorporated herein by reference, is hereby annexed to the Fronerty as defined in the Declaration, and is hereby submitted to, and shall be governed by, the provisions of the Declaration.
- 2. Exhibit "A-1" of the Declaration is hereby amended by adding thereto the Common Areas located upon the first Additional Property. The amended legal description of the Common Areas including the Common Areas located on the First Additional Property is attached hereto as Exhibit "A-1". The Common Areas located upon the First Additional Property are hereby annexed to the Property as defined in the Declaration, and are hereby submitted to, and shall be governed by, the provisions of the Declaration.
- 3. The remaining Additional Prope ty, lescribed in Exhibit "B" of the Declaration and incorporated herein by reference, will remain at nature Additional Property and is not subject to this First Amendment. There is no Exhibit "B" made a part of this First Amendment.
- 4. Exhibit "C" of the Declaration is hereby (mended by adding thereto Exhibit "C", attached hereto and incorporated herein by reference, which shows the boundaries of the Property including the First Additional Property. Exhibit "C" of the Declaration which depicts the original Property shall remain in full force and effect, as the search may be amended from time to time.
- 5. Exhibit "D" of the Declaration is hereby amended by substituting therefore Exhibit "D", attached hereto and incorporated herein by reference, which ame ids the percentage allocated to each Townhouse to include all previous Townhouses located upon the Property and the additional Townhouses located or to be located upon the First Additional Property.
- 6. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
