CUNTRACTOR'S CLAIM FOR MECHANIC'S LIEN

Michigan Chicago, IL 60616, and Shifti Agrawal, an individual, whose address is Four Sylvan Glen Court, Burr Ridge, IL 60521 (Collectively "Owners"); Wells Fargo Bank, N.A., as Trustee for Morgan Stanley Capital (Lic., Commercial Mortgage Pass-Through Certificates, Series 2006-IQ12, with and address of 1015 10th Avenue SE, Minneapolis, Minnesota 55414, and Puritan Finance Corporation, an Illinois corporation located at 55 W. Monroe St. Suite 3590, Chicago, IL 60603 (Collectively "Lenders"); Unknown Owners; and Non-record Claimants and against the interest of any person claiming an interest in the Real Estate (as hereinafter described) by, through or under Owner.

Claimant states as follows:

1. At all times relevant hereto and continuing to the present, Owner owned the following described land in the County of Cook, State of Illinois, to wit:

- 2. On or about January 22, 2007 said Owner entered into a contract with the Claimant Mugnaini Painting & Remodeling Inc., for certain improvements to said Real Estate, to provide all the necessary material and labor for patching and painting of apartments in exchange for payment.
- 3. The contract was entered into by Owner and the work was performed by Claimant Mugnaini Painting & Remodeling Inc., with the knowledge and consent of

Owner. Alternatively, the Owner specifically authorized its agents to enter into contracts for improvement of the Real Estate. Alternatively, the Owner knowingly permitted its agents to enter into contracts for the improvement of the Real Estate.

- 4. On or about April 27, 2007, the Claimant Mugnaini Painting & Remodeling Inc., substantially completed all work required to be performed under its contract, which entailed materials, painting and patching for apartments for which the amount of Three thousand Dollars (\$3,000.00) remains unpaid.
- 5. As of this date, there is due, unpaid and owing to the Claimant Mugnaini Painting & Remodeling Inc., after allowing all credits, the sum of Three thousand Dollars (\$3,000.00), which principal amount bears interest at the statutory rate. Claimant Mugnaini Painting & Remodeling Inc., claims a mechanics lien on said Real Estate and improvements and on the monies or other consideration due or to become due from the Owner under said contract, and others claiming an interest in said property.
