#### **MEMORANDUM OF LEASE**

Arboretum of South Barrington, LLC, a Delaware limited liability company, as landlord ("Landlord"), and Village Roadshow Gold Class Cinemas LLC, a Delaware limited liability company, as tenant ("Tenant"), have entered into a Lease dated June 12, 2007 (the "Lease"), wherein Landlord leased to Tenant the premises depicted on Exhibit A attached hereto (the "Leased Premises"), together with all tenements, hereditaments and other rights appurtenant to the Leased Premises. The Leased Premises are situated in The Arboretum (the "Shopping Center"), a retail commercial complex located in the City of South Barrington, County of Cook and State of Illinois (the Shopping Center is depicted on Exhibit A). A legal description of the Shopping Center also is included in Exhibit A. The primary term of the Lease commences on the date specified in the Lease (the "Commencement Date") and shall expire fifteen (15) years after the Commencement Date, subject to four (4) options to renew for successive, additional periods of five (5) years each.

Pursuant to the Lease, Landlord is not permitted to alter or reconfigure the Protected Area shown on Exhibit A without the prior written consent of Tenant. The Lease also provides that Landlord shall not enter into a lease or consent to the use or occupancy of any other space within the Shopping Center by another tenant, subtenant, assignee, licensee or concessionaire whose principal business is the operation of a motion picture theater or entertainment complex, subject to certain limitations set forth in the Lease, to which reference is here made for a more particular delineation of such terms.

The terms and provisions of the Lease not described herein are more particularly set forth in the Lease, to which reference is here made for all purposes. This Memorandum is being recorded in the Official Records of Cook County, Illinois in order to give notice of the provisions of the Lease, and shall not be deemed to amend or modify the Lease in any respect.




