5. (X) This power of attorney shall become effective upon execution.


6. (X) This power of attorney shall terminate upon the completion of the sale of the aforesaid property and the distribution of the net proceeds.

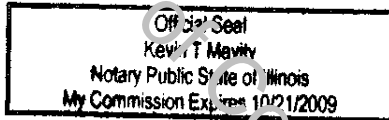
