THIRD AMENDMENT TO REDEVELOPMENT AGREEMENT

This Third Amendment to Redevelopment Agreement ("Third Amendment") is entered into as of this 222 day of 2007, by and between the City of Chicago, an Illinois municipal corporation (the "City") acting through its Department of Housing ("DOH"), having its offices at 33 North LaSalle Street, Chicago, Illinois 60602, and Breaking Ground, Inc., an Illinois not-for-profit corporation, having, its principal office at 3601 West Fillmore, Chicago, Illinois 60624 ("Developer").

RECITALS

- A. The City and the Developer have previously entered into that certain Redevelopment Agreement dated as of November 16, 2005 and recorded in the Recorder's Office of Cook County on November 21, 2005 as document No. 0532535251, which has been previously amended by the First Amendment to the Redevelopment Agreement entered into as of January 30, 2006 recorded on March 9, 2006 as document No.0606827012, and the Second Amendment to the Redevelopment Agreement entered into as of May 15, 2007 and recorded on May 25, 2007 as document No. 0714560007.
- B. Pursuant to the terms of the Redevelopment Agreement, simultaneously with the recording of this Third Amendment, the City is conveying to the developer five lots legally described on Exhibit A to this Third Amendment.
- C. This Third Amendment is being recorded to provide the legal descriptions for certain parcels identified on Exhibit A, of the original Redevelopment Agreement and which have been previously encumbered by the lien and encumbrance of the Redevelopment Agreement.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein and in the Redevelopment Agreement, the parties agree as follows:
