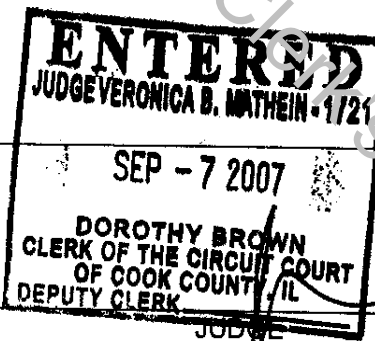

It is hereby ordered:

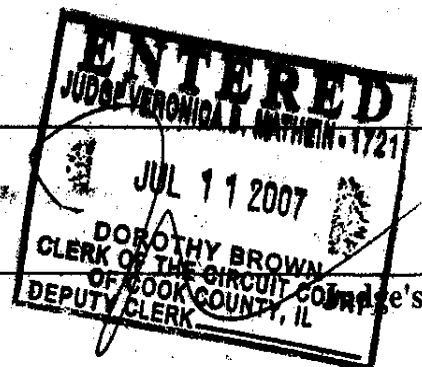
