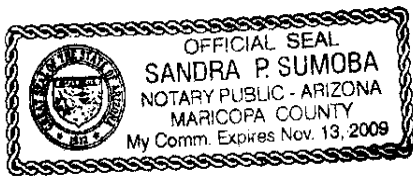

LEGAL DESCRIPTION
