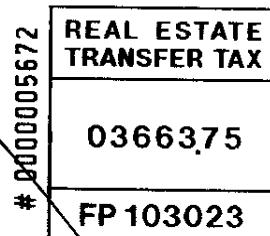
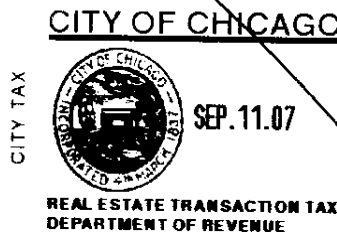
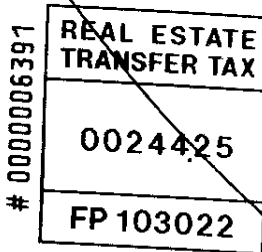
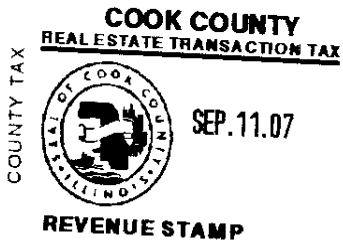
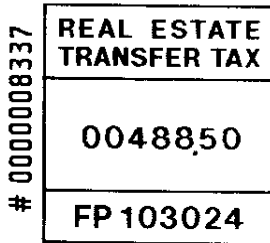
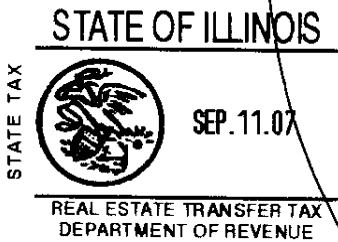
TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto Grantee, forever.



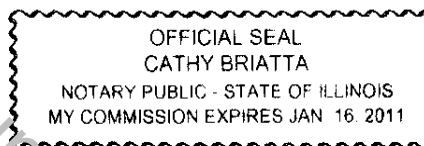
