
1. That on May 5, 2007, the Claimant made a contract with said Owner to perform the following work:

2. On May 5, 2007 said Owner made a deposit payment of Seven Hundred Dollars and no cents (\$700.00) in the form of a personal check number 0092 drawn on the Bank of America.
3. On May 23, 2007 said personal check was returned "Insufficient Funds" through Republic Bank of Chicago, the bank of Continental Windows.


