

WHEREAS, The City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of part of public street caribed in the following ordinance; now, therefore,

SECTION 3. The City of Chicago hereby reserves that part of the public street as herein vacated, as a right-of-way for existing city electrical facilities, and for the maintenance, renewal and reconstruction of said facilities or the construction of additional municipally-owned electrical facilities. It is further provided that no buildings or other structures shall be erected on the said right-of-way herein reserved or other use made of said area which in the judgment of the respective municipal officials having control of the aforesaid expice facilities would interfere with the use, maintenance, renewal, and reconstruction of said facilities, or the construction of additional municipally-owned service facilities.

SECTION 4. The City of Chicago hereby reserves for the barefit of The Peoples Gas Light and Coke Company the right to abandon in place all or any part of the existing gas mains, service piping, associated equipment and appur tenances and all or any portion of its equipment as may be located over, through, which, along and across the vacated area. It is further provided that all costs and expenses associated with the removal of any abandoned main, pipe, appurtenances or equipment shall be borne exclusively by the beneficiary, its successors and assigns and not by The Peoples Gas Light and Coke Company.

The City of Chicago hereby reserves for the benefit of Commonwealth Edison Company, SBC and Comcast and their successors or assigns, an easement to operate, maintain, construct, replace, and renew overhead poles, wires and associated equipment and underground conduit, cables and associated equipment for the transmission and distribution of electrical energy and telephonic and telecommunications and associated services under, over and along that part of the street as herein vacated, with the right of ingress and egress.

SECTION 5. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, The Illinois Medical District Commission shall deposit in the City Treasury of the City of Chicago a sum sufficient to defray the costs of removing paving and curb returns
