UNIFORM COVENANTS.

Mortgagor and Lener covenant and agree as follows:

- 1. PAYMENT OF PRINCIPAL AND INTEREST. Mortgagor shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.
- <u>2. APPLICATION OF PAYMENTS.</u> Unless applicable law provides otherwise, all payments received shall be applied by Lender first to interest payable on the Note and then to the principal of the Note.
- 3. PRIOR MORTGAGES AND DEEDS OF TRUST. Mortgagor shall perform all of Mortgagor's obligations upder any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage, including Mortgagor's covenants to make payments when due. - 7. INSPECTION. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Mortgagor notice prior to any such inspection specifying reasonable cause therefore related to Lender's interest in the Property.
- 8. CONDEMNATION. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender, subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage.
- 9. MORTOAGOR NOT RELEASED; FORBEARANCE BY LENDER NOT A WAIVER. Lender, at Lender's option, may require Mortgagor to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Mortgagor may have against parties who supply labor, materials or services in connection with improvements made to the Property.
- 15. TRANSFER OF THE PROPERTY. 17. MORTGAGOR'S RIGHT TO REINSTATE. The receiver shall be liable to account only for those rents actually received.

- 19. RELEASE. Upon payment of all sums secured by this Mortgage, Lender shall release this Mortgage without charge to Mortgagor. Mortgagor shall pay all costs of recordation, if any.
- 20. WAIVER OF HOMESTEAD. Mortgagor hereby waivs all right of homestead exemption in the Property.
