## EXHIBIT A

## LEGAL DESCRIPTION

The East 140 feet of that part of Lot 1 in Wehacker's Subdivision of parts of Sections 29 and 32, Township 33 North, Range 16 East of the Third Principal Meridian in Cook County, Illinois, according to the plat thereof recorded June 17, 1933, as Document No. 5309284 in Book 124 of Plats, Page 8, falling within the East 5 chains of Section 32 aforesaid excepting therefrom the following:

Corner being at a point on the South right-of-way line of Ridge Road which is 120.00 feet West of the Indiana-Illinois State Line; thence Southeastery along such South right-of-way line a distance of 121.84 feet, more or less, to the Indiana-Illinois State Line; thence South along the Indiana-Illinois State Line a distance of 125.00 feet to a point; thence Northwest (by line) parallel to the South right-of-way line of Ridge Road a distance of 121.84 feet, more or less, to a point which is 120.00 feet West of the Indiana-Illinois State Line; thence North and parallel to the Indiana-Illinois State Line a distance of 125.00 feet to the point of beginning, in Cook County, Illinois.

Part of the West half of Section 24, Township 36 North, Range 10 West of the Second Principal Meridian in the Town of Munster, Lake County, Indiana, being particularly described as beginning at the intersection of the South Right-of-Way line of Ridge Road and the West line of said Section 24, which is 1,166.01 feet, more or less, South of the Northwest corner of said Section 24, thence South 34 degrees 34 minutes 03 seconds East, along said South Right-of-Way line a distance of 348.07 feet; thence South 00 degree 11 minutes 18 seconds East, along the West line of Elmin Addition, to the Town of Munster, as shown in Plat Book 68, page 11, in the Office of the Recorder of Lake County, Indiana, a distance of 468.13 feet; thence North 00 degree 45 minutes 42 seconds West, a distance of 348.42 feet, to a point on the West line of said Section 24, said line also being the Indiana-Illinois State Line; thence North 00 degree 00 minutes 00 seconds East, along previously described line, a distance of 467.07 feet, to the point of beginning, all in the Town of Munster, Lake County, Indiana.
