AMENDMENT TO 1736 DECLARATION AND BY-LAWS OF-2136 W. AUGUSTA CONDOMINIUM ASSOCIATION, CHICAGO, IL

This Amendment to Declaration and By-Laws is made and entered into this 12th day of September, 2007, by 1736 W. Augusta L. L. C. to reflect the following modifications:

1. Section I, Paragraph 11 f of the Declaration shall read as follows:

f. No animals, livestock, fowl, or poultry of any kind shall be raised, bred, or kept in any Unit or in the Common Elements, except that household pets, other than dogs or cats, may be kept in Units, subject to rules and regulations actor ted by the Association, which rule or regulation may exclude any kind of pet by type or category, other than cats and dogs, provided that permitted household pets are not kept, bred, or maintained for any commercial purpose; and provided further that any such authorized pet causing or creating a nuisance or unreasonable disturbence shall be permanently removed from the Property on three (3) days' written notice from the Association. Dogs of that are kept in Units as of the date this Declaration is Recorded and dogs and cats owned by grantees of the 17.6 AUGUSTA LLC of Glenview at the time Units are conveyed to such grantees may be kept in Units subject to the terms of this paragraph, but once the dog or cat dies or is otherwise no longer kept in a Unit, the Unit Owner owning the cose of the Association.

- 2. Paragraph 28 is added to Declaration as foliows:
- 28. The roof deck over the garage shall be a limited common element appurtenant to and for exclusive use of Unit 1.
- 3. Article II, Section 2 (b) of the Bylaws is amended to read as follows:

Commencing with the date of the first annual meeting of the members, the 'otal rumber of votes of all members shall be two (2). Each unit shall be entitled to one (1) vote.

4. Article XV is added to By-Laws as follows:

In the event that the unit owners are unable to reach an agreement upon the voting of any issue governed by the Declaration the matter shall be settled by arbitration in accordance with the Rules of the Illinois Uniform Arbitration Act, with the disputants to share equally in the costs of arbitration.
