- 14. Governing Law; Severability. The extension of credit secured by this Mortgage is governed by federal law, which for the purposes of 12 USC § 85 incorporates Ohio law. - F. Remedies. If Mortgagor does not pay condo ninium dues and assessments when due, then Lender may pay them. Any amour is disbursed by Lender under this paragraph F shall become additional deat of Mortgagor secured by the Security Instrument. Unless Mortgagor and Lender agree to other terms of payment, these amounts shall bear interest from the late of disbursement at the rate of interest or finance charge set forth in the local and shall be payable, with interest, upon notice from Lender to Mortgagor requisiting payment.
