THIRD AMENDMENT TO MORTGAGE AGREEMENT, COLLATERAL ASSIGNMENT OF RENTS AND LEASES, AND SECURITY AGREEMENT

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

SECTION 1 EFFECT OF THIRD AMENDMENT

1.1. This Third Amendment amends the Loan Documents as provided herein. The terms of this Third Amendment shall govern in the event of any conflict with the terms of any of the Loan Documents. All capitalized terms used herein and not otherwise defined shall have the meaning ascribed thereto in the Loan Documents. The terms of this Third Amendment shall be effective as of the date hereof. Except as amended herein, the Loan Documents shall remain in full force and effect and shall be incorporated herein and made a part hereof by reference. All references in any of the Loan Documents to a particular document shall be deemed to include this Third Amendment. Borrower agrees that any and all security interests granted in the Loan Documents shall remain in full force and effect and are unimpaired. By Borrower's execution of this Third Amendment, Borrower affirms all of the representations, warranties, covenants and terms of the Loan Documents, and confirms the accuracy or compliance of such provisions as if entered into as of the date of this Third Amendment.

SECTION 2 AMENDMENTS TO MORTGAGE AGREEMENT

2.1. The "WHEREAS" clause of the Mortgage Agreement is herby stricken and replaced with the following:

"WHEREAS, Mortgagor is justify indebted to Mortgagee in an aggregate principal sum of up to Eight Million One Hundred Thousand and No/100 Dollars (\$8,100,000.00) pursuant to a Third Amended and Restated Promissory Note dated June 17, 2007 (the "Note"). The Note is riade payable to the order of and delivered to Mortgagee, and is payable together with interest thereon, from the date thereof, at the rate, in installments, and in accordance with all other terms set forth therein and in a certain Loan Agreement dated December 17, 2004, by and between Mortgagor and Mortgagee (as amended from time to time, the "Loan Agreement"). All terms and conditions of the Loan Agreement are hereby incorporated herein by this reference."

2.2. Section 37 of the Mortgage is hereby amended by changing "Type 17, 2007" to "February 17, 2008".

SECTION 3 AMENDMENTS TO COLLATERAL ASSIGNMENT

3.1. Section 1 of the Collateral Assignment is amended by revising the following definitions as set forth below:

<u>Loan Agreement</u>. The definition shall be replaced in its entirety by the following:

"That certain Loan Agreement of even date herewith, as amended from time to time, by and between the Assignor and the Assignee pursuant to which the Assignee has agreed, subject to the terms and conditions thereof, inter alia, to make a loan to the Assignor in the principal amount of Eight Million One

SECTION 4 AMENDMENTS TO THE SECURITY AGREEMENT

The second "WHEREAS" clause of the Security Agreement shall be replaced in its entirety by the relieving:

"WHEREAS, in connection with the Property, Lender is making a secured loan to the Borrower in a principal sum of Eight Million One Hundred Thousand and No/100 Dollars (\$8,100,000.00) evidenced by that certain Third Amended and Restated Promissory Note dated June 17, 2007 (as amended from time to time, the "Note"), Assignment of Leases and Rents, this Security Agreement, and other loan documents, all of even date herewith (collectively, as amended from time to time, the "Loan Documents"); and"

SECTION 5 GENERAL PROVISIONS

Except as modified herein, the terms and conditions of the Mortgage, Collateral 5.1 Assignment, and Security Agreement shall be and remain unclanged and in full force and effect as written. Nothing herein contained shall in any manner affect the raiority or lien of the Mortgage, Collateral Assignment, or Security Agreement, or the covenants, conditions and agreements therein contained. 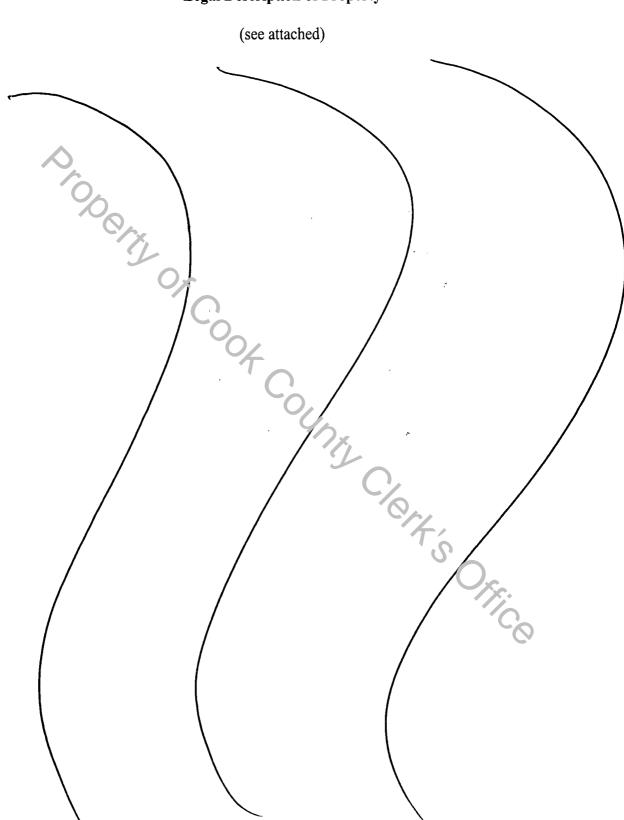
