- 1. Mortgagor shall (1) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the Property which may become damaged or be destroyed; (2) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof; (3) pay when due any indebtedness which discharge of such prior lien to Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said Property; (5) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof; (6) make no material alterations in said Property except as required by law or municipal ordinance.

In case of default therein, Mortgagee may, but need not, make very payment or perform any act hereinbefore required of Mortgagor in any form and manner deemed expedient, and may, but need not, ranke full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise, or settle any text lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said Property or contest any tax of as sessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged Property and the lien hereof, shall one with additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest there on at the highest rate now permitted by lilinois law.
