## EXTENSION AGREEMENT

- 2. The interest rate set forth on the first page of the Articles shall be and is hereby amended to read SEVEN AND ONE HALF PERCENT (7.50%), per annum, deleting the reference to SEVEN PERCENT (7%).
- 3. The parties agree that payments of the balance due shall be extended and paid as follows:

(\$2,658.41) on or hefe e the 1st day of Deteber 2007, and Two Thousand Six Hundred Fifty Eight Dollars and  $\pm 1/100$  (\$2,658.41) on or before the 1st day of each month thereafter with a Snal payment of principal and interest and all amounts due , if not sooner paid, on or pefore September 1<sup>st</sup>, 2009.

- 4. All other terms and provisions of the Articles of Agreement for Deed shall be applicable to this extension period without modification or revision, and except as provided herein, the Articles of Agreement for Deed and any other documents, previously executed between the parties and applicable hereto, shall continue in full torce and effect
