**PAINTER'S CLAIM FOR MECHANICS LIEN**

WHEREFORE, on or about the contract date of August 29, 2007 and subsequent thereto, Owner represented himself as the legal owner, and Owner was in fact the principal agent of Amaya Investment Group, LLC (involuntarily dissolved), the legal title holder of record of said real estate;

WHEREFORE, the contract provided, in pertinent part, that Claimant was to perform the following with regard to the real estate: (see attached "Proposal")

WHEREFORE, Claimant began performance on or about Sept. 5, 2007, and has suspended further performance due to Owner's breach (ie. by making partial payment with an invalid check and failing to cure upon notice);

WHEREFORE, under the terms of the contract, the total unpaid balance due to Claimant from Owner is \$7,000.00 as of this date.

NOW THEREFORE, Claimant hereby files notice and claim for lien against the subject real estate and the improvements thereupon, and against the interests of Owner and any other interested parties, in the amount of \$7,000.00, plus interest if allowable by law.

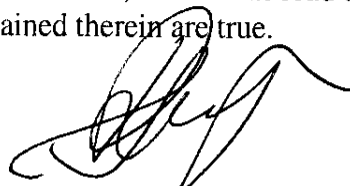

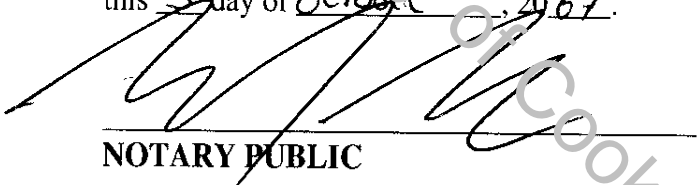
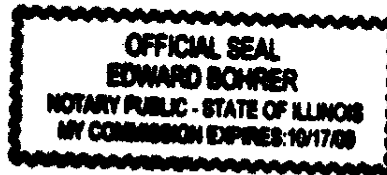
