- 2. The registered office must include a street or road address; a rost office box number alone is not acceptable.
- 3. A corporation cannot act as its own registered agent.
- 4. If the registered office is changed from one county to another, then the corporation must file with the recorder of deeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY rom the Secretary of State.
- 5. Any change of *registered agent* must be by resolution adopted by the board of direct rs. This statement must then be signed by a duly author ized officer.
- 6. The registered agent may report a change of the registered office of the corporation for which he or she is registered agent. When the agent reports such a change, this statement must be signed by the registered agent, if a corporation is acting as the registered agent, a duly authorized officer of such corporation must sign this statement.
