#### THIRD MEMORANDUM OF MODIFICATION AND EXTENSION AGREEMENT

(PIN Nos.: 17-08-238-011-0000 -and-18-09-114-027-0000)

THIS THIRD MEWORANDUM OF MODIFICATION AND EXTENSION AGREEMENT is executed as of Sep'ember 27, 2007, by and among JAMES KLUN, individually ("Borrower"), KERRI KLUN, as Porrower's wife ("Kerri Klun"), and HERITAGE COMMUNITY BANK, an Illinois banking corporation ("Zender").

#### WITNESSETH:

WHEREAS, on or about May 2, 2006, Lender made a loan to Borrower in the original principal amount of ONE MILLION FIFTY THOUSAND AND NO/100 DOLLARS (\$1,050,000.00) (the "Loan") to refinance an existing mortgage covering a three-unit apartment building which has been converted to single-family condominium units for sale and a coach house which has been remodeled for sale (the "Project"), located at 519 North May Stress, Chicago, Illinois 60622, as legally described on Exhibit A attached hereto (the "Land"); and

WHEREAS, the Loan is evidenced and secured by the following incruments, each dated as of May 2, 2006, unless otherwise noted ("Loan Instruments"):

- 1. Promissory Note executed by Borrower and payable to the order of Lender in the principal amount of ONE MILLION FIFTY THOUSAND AND NOTICE DOLLARS (\$1,050,000.00) (the "Note");
- 2. Mortgage executed by Borrower and Kerri Klun, jointly as Grantor, to and for the benefit of Lender covering the Land, and recorded in the Cook County Recorder's Office, Cook County, Illinois, on May 4, 2006, as Document No. 0612404139 (the "Mortgage");
- 3. Assignment of Rents and Leases executed by Borrower and Kerri Klun, jointly as Grantor, to and for the benefit of Lender covering the Land, and recorded in the Cook County Recorder's Office, Cook County, Illinois, on May 4, 2006, as Document No. 0612404140;
- 4. Agreement to Provide Insurance executed by Borrower and Kerri Klun to and for the benefit of Lender;

- 5. ALTA Loan and Extended Coverage Policy Statement executed by Borrower and Kerri Klun to and for the benefit of Lender;
- 6. Notice of Final Agreement executed by Borrower, Kerri Klun and Lender;
- 7. Disbursement Request and Authorization executed by Borrower; and
- 8. Any and all other documents or instruments given at any time to evidence and secure the Loan.

WHEREAS, the terms and provisions of the Loan Instruments were modified and amended by the Memoran hum of Modification dated as of March 2, 2007, and recorded in the Cook County Recorder's Office Cook County, Illinois, on April 10, 2007, as Document No. 0710047009 (the "First Memorandum of Modification"), whereby: (a) the real property located at 635 South Ashland Avenue, LaGrange, Illinois 60525, legally described on Exhibit B attached hereto (the "Ashland Avenue Property"), wis added as additional collateral to secure the Loan, as evidenced by the Junior Mortgage dated as of Murch 2, 2007, and recorded in the Cook County Recorder's Office on April 10, 2007, as Document No. 0710047010; (b) the interest-only monthly payments due under the Note were reduced; and (c) the Maturity Date of the Loan was extended to August 2, 2007; and

WHEREAS, the terms and provisions of the Loan Instruments were further modified and amended by the Second Memorandum of Modification and Extension Agreement dated as of August 1, 2007, and recorded in the Cook County Recorder's Office, Cook County, Illinois, on August 22, 2007, as Document No. 0723447001 (the "Second Memorandum of Modification"), whereby: (a) the Maturity Date of the Loan was extended to October 31, 2007, and (b) the interest-only monthly payments due under the Note were further adjusted; and

WHEREAS, as of the date of this Agreement, there is an outstanding principal balance due on the Note in the amount of ONE MILLION THIRTY-ONE THOUSAND FOUR HUNDRED NINETY-FOUR AND NO/100 DOLLARS (\$1,031,494.00); and

WHEREAS, Lender and Borrower have agreed to further modify and amend the Loan Instruments as hereinafter provided;

**NOW, THEREFORE,** in consideration of the mutual covenants and agreements of the parties hereto, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

- 1. <u>Modification of Loan Instruments</u>. Subject to the terms and provisions contained herein, the terms and provisions of the Loan Instruments are hereby further modified and amended, effective as of the date hereof, so as to provide as follows:
  - (a) <u>Maturity Date</u>. The Maturity Date of the Loan is hereby <u>further extended</u> to February 29, 2008.
  - (b) <u>Interest-Only Monthly Payments Due Under Note</u>. The interest-only monthly payments due under the terms of the Note are hereby fixed at \$1,500.00 per month commencing October 2, 2007, and continuing through February 2, 2008, with a final payment of principal and all unpaid and accrued interest due and payable in full on or before February 29, 2008.

- 2. <u>Reaffirmation of Loan Instruments</u>. Except as expressly provided herein, Borrower, Kerri Klun and Lender hereby reaffirm and incorporate herein by reference each and every term, provision, representation and warranty contained in the Loan Instruments, and Borrower and Kerri Klun agree that said terms, provisions, representations and warranties shall remain in full force and effect.
- 3. <u>Attorneys' Fees and Costs</u>. Borrower shall pay any and all attorneys' fees and costs incurred by Lender in connection with the preparation, negotiation and perfection of this Agreement and any other documents executed in connection therewith, including recording and title charges, if any.
- 4 <u>Counterparts</u>. This Agreement may be executed by the parties hereto in any number of counterparts, each of which shall constitute an original, but all of which, when taken together, shall constitute one and the same instrument.
