PARCEL 2: THE EXCLUSIVE RIGHT TO THE USE OF PARKING SPACE P-265, A LIMITED COMMON ELEMENT, AS DELINEATED AND DESCRIBED IN THE SURVEY ATTACHED TO THE DECLARATION OF CONDOMINIUM OWNERSHIP, AFORESAID.
