MODIFICATION OF MORTGAGE

THE EQUITY LINE CREDIT AGREEMENT AND DISCLOSURE, AS DESCRIBED IN THE MORTGAGE STATED ABOVE, WITH A CREDIT LIMIT OF \$17,500.00, AND A CURRENT BALANCE OF \$17,666.13 IS HEREBY MODIFIED AND INCREASED TO A CREDIT LIMIT OF \$48,500.00.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

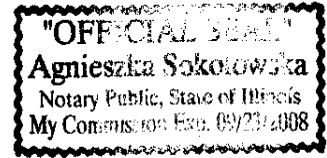

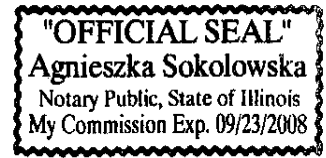

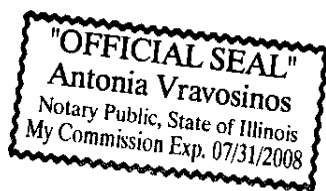
