CCLLATERAL ASSIGNMENT OF LEASES AND RENTS

THIS COLLATERAL ASSIGNMENT OF LEASES AND RENTS made June 17, 2007 (this "Assignment"), by ROBERT LEVIN, an Illinois resident whose address is 2122 Old Glenview Road, Wilmette, Illinois, and ROSA B. LEVIN, an Illinois resident whose address is 2122 Old Glenview Road, Wilmette, Illinois (Robert Levin and Rosa B. WITNESSETH:

Section 1. <u>Definitions</u>. Each reference in this Assignment to the following terms shall be deemed to have the following meanings and all other references shall have the meaning assigned thereto in the Loan Agreement defined below.

<u>Lease</u>: Each agreement providing for the use and occupancy of the Leased Premises, in writing or oral, now or hereafter existing, affecting any portion or all of the Leased Premises and any modifications, amendments, renewals and extensions thereof or agreements in substitution for any of the foregoing.

<u>Note</u>: That certain secured Third Amended and Restated Promissory Note in the principal sum of Eight Million One Hundred Thousand and No/100 Dollars (\$8,100,000.00) of Borrower, payable to the order of Assignee and of even date herewith.

Obligations: Payment of the principal, interest and any other sums now or hereafter due and payable to Assignee under the Note, the Loan Agreement, the Security Documents, this Assignment and/or any other agreements between Borrower and Assignor, on the one hand, and Assignee, on the other hand, now or here after existing and performance and satisfaction of all other agreements, warranties, representations and obligations of Borrower and/or Assignor contained in this Assignment, the Loan Agreement, the Note, the Security Documents, any Lease, and/or any other agreements of Assignor and/or Borrower, now or hereafter existing, and relating to the Note, Loan Agreement, the Security Documents, any Lease, and/or the Leased Premises.

Security Documents: Collectively, all of the Security Instruments (as defined in the Loan Agreement), including, without limitation, the Junior Mortgage Agreement granting Assignee a second mortgage and security interest as to the Leased Premises and form UCC-1 financing statements relating thereto, and all other documents, instruments and agreements now or hereafter executed and/or delivered by Assignor for the purpose of granting Assignee security for the Obligations.

WHEREAS, Robert Levin is a guarantor and member of Borrower, and Assignor desires Lender to extend or continue the extension of credit to Borrower, and hereby represents and warrants that such extension or continuation of credit to Borrower will, directly and materially, inure to the financial benefit of Assignor; and

WHEREAS, Lender requires, as a condition precedent to its advancing funds pursuant to the Loan Documents, that Assignor enters into this Agreement;

NOW, THEREFORE, in consideration of the Loan Agreement, the loan pursuant thereto and other valuable consideration, the receipt of which is hereby acknowledged and as further security for payment and performance of the Obligations, Assignor hereby grants, sells, conveys, transfers, assigns and sets over to Assignee all of Assignor's rights, title and benefits under, in and to each Lease, the Rents and any present or future guarantees of any Lease and Rents;

TO HAVE AND TO HOLD the same with all of the rights, privileges and appurtenances thereunto belonging unto Assignee, its successors and assigns until such time as the Obligations have been paid and satisfied in full for the purpose of further and collaterally securing the same.

Assignor and Assignee agree that the following terms and conditions shall govern this Assignment:

- 1. Assignor's Covenants. Assignor, for itself and for its successors and assigns, covenants and warrants ac follows:
- (a) That each existing Lease is in full force and effect and that there is to the knowledge of Assignor, no default on the part of any party thereto;
- (b) That Assignor is the cole owner of the entire lessor's interest under each existing Lease, that each existing Lease is free from all encumbrances and liens, except as provided in any Lease, other than the Security Documents, that Assignor has full power and authority to assign each Lease and Rents in accordance herewith, that Assignor will warrant and defend each Lease and Rents to Assignee against the lawful claims and demands of all persons, and that, except for that certain mortgage dated <u>September 17,2001</u> and recorded <u>September 19,2001</u> as Document Number <u>0126233010</u>, by Assignor to The PrivateBank and Trust Company, Assignor has not sold, assigned, transferred, mortgaged or pledged any Lease and/or Rents or any interest thereon, whether now or hereafter to become due, to any person, firm or corporation other than Assignee;
- (c) That no Rents becoming due after the date hereof have been collected, nor has payment of any of the same been anticipated, waived, released, discounted or otherwise discharged or compromised;
- (d) That Assignor will not assign, pledge or otherwise encumber any Lease or any of the Rents without the prior written consent of Assignee in each instance and then only subject to and in accordance with any conditions set forth in such written consent;
- (e) Upon an Event of Default under the Security Documents, Assignor will not, without the prior written consent of Assignee in each instance directly or indirectly amend, modify, cancel, terminate or accept any surrender of any Lease or waive or consent to any default or variation in the performance thereof, but that Assignor will enforce all of the terms and conditions thereof at all times;
- (f) If Assignee grants Assignor a license pursuant to Section 2 hereof, Assignor will not in any way violate or permit a violation of such license;

- (g) That Assignor will fulfill or cause to be fulfilled all of the terms, covenants and conditions on Assignor's part to be fulfilled under each Lease;
- (h) That Assignor will, upon written request by Assignee, while this Assignment remains in force and effect, execute and deliver all such powers of attorney, instruments of pledge or assignment, and such other instruments or documents as Assignee may reasonably request at any time for the purpose of further securing Assignee's rights hereunder; and
- (i) That Assignor will provide Assignee with written notice of any extension, renewal, amendment or modification of any Lease within five (5) days thereof, and that Assignor will similarly furnish to Assignee, on demand, true copies of all agreements or letters effecting same.
- 2. <u>Licence to Lease</u>. So long as no Event of Default shall exist under any of the documents under which the Obligations arise, Assignee may, in its sole discretion, grant Assignor a license to lease the Leased Premises pursuant to each Lease, to exercise Assignor's rights as lessor thereunder, and to collect all Rents and receipt therefor; <u>provided</u>, <u>however</u>, that without the prior written consent of Assignee in each instance Assignor shall not collect any installment of Rents more than thirty (30) days in advance of the due date prescribed for the payment thereof in any Lease.

3. Assignee's Rights in Event of Γ efault.

- 3.1 Upon three (3) days' notice after the occurrence of any event of default after the expiration of any applicable grace period under any of the documents under which the Obligations arise, and until such event of default shall have been cured as hereinafter defined, the license under Section 2 hereof shall, at the option of Assignce, terminate and in such event Assignee is hereby expressly and irrevocably authorized to enter and take possession of the Leased Premises by actual physical possession, or by notice in accordance with Section 9 hereof to Assignor without further authorization, notice or demand and without the commencement of any action to foreclose any of the interests granted in any of the Security Documents or to exercise its power of sale and other remedies thereunder.
- 3.2 Upon an event of default under any of the Security Documents, Assignor hereby constitutes and appoints Assignee irrevocably, and with full power of substitution and revocation, the true and lawful attorney, for and in the name, place and stead of Assignor, to demand and receive any and all Rents; to enter into any and all agreements with any Lessee or any other party at any time for the disposition of the Rents; to compromise and adjust any other sums due or to become due in connection therewith; and to give all such receipts, releases, assurances, acquittances, discharges and other instruments that any Lessee or any other party may require for the Rents and other sums or any part thereof; to enforce, amend or terminate any Lease and enter into any agreements or new Lease in substitution for or in addition to any Lease; to exercise all rights and remedies of Assignor under any Lease; to construct, complete, repair and/or alter the Leased Premises as Assignee may, in its reasonable discretion, deem proper; to perform any of the actions and rights provided by any of the Security Documents in the event of

a default thereunder; to pay, from and out of the Rents or from or out of any other funds, any taxes, assessments, water, sewer or other government charges assessed or imposed against the Leased Premises and also any and all other charges and expenses which may be necessary or advisable for Assignee to pay in the construction, completion, management or operation of the Leased Premises, including, without limitation, the costs of such construction, completion, repairs and alterations, commissions for renting or selling the Leased Premises or any portions thereof and legal expenses of exercising such rights and remedies. Assignor hereby grants unto said attorney full power and authority to do and perform each and every act whatsoever requisite to be done in and about the Leased Premises, as fully to all intents and purposes, as Assignor could do if personally present, hereby ratifying and confirming all that said attorney shall lawfully do creause to be done by virtue hereof; provided, however, that any acts or omissions by Assignee after an event of default shall be at Assignee's discretion and shall not be or become the basis for any lightlity of Assignee. Assignor hereby authorizes and directs each Lessee and all other parties to pay and deliver all Rents and other sums due and to become due to Assignor under each Lessee's Lesse's Assignee in accordance with the provisions hereof.

- Assigned shall apply the net amount of Rents received by it from the Leased Premises and/or under any Lease, after payment of all proper costs and charges (including, without limitation, any liability, loss, expense or damage hereinafter referred to in Section 4 hereof), in such order and in such proportion as Assignee shall elect in accordance with the Loan Agreement, including, without limitation, to the Obligations then due and to the payment when due, of interest payable under the Note and thereafter to the payment of the principal due under the Note. Any of such funds remaining after such application shall be paid as soon as reasonably practicable by Assignee to Assignor or at Assignor's direction set forth in Notice from Assignor.
- 3.4 Assignee shall be accountable to Assignor only for funds actually received by Assignee pursuant to this Assignment and the acceptance of this Assignment shall not constitute a satisfaction of all or any part of the Obligations except to the extent of funds actually received and applied by Assignee on account of the same.
- 3.5 The rights and powers of Assignee hereunder shall continue and remain in full force and effect until all Obligations, including any deficiency resulting from exercise of remedies under any of the Security Documents, are paid or satisfied in full, and shall continue after commencement of foreclosure and after foreclosure sale and until expiration of the equity of redemption, notwithstanding sale of the Leased Premises to a purchaser other than Assignee. Assignee shall not be liable to Assignor or anyone claiming under or through Assignor by reason of any act or omission by Assignee hereunder.
- 3.6 An event of default shall be cured only when Assignor shall have paid and/or satisfied in full all Obligations and other sums owing and past due and/or shall have performed all other terms, covenants and conditions, the event of default of which terminates the license hereinabove mentioned.

4. Indemnification.

- 4.1 Assignor agrees to indemnify, defend and hold harmless Assignee from and against any and all liability, loss, damage and expense, including reasonable attorneys' fees which Assignee may or shall incur under or in connection with any Lease and/or the Leased Premises or by reason of any of the Obligations or actions taken or omitted by Assignee under any of the Obligations, including, without limitation, any action or omission which Assignee in its discretion may take to protect its interest in any Lease and/or the Leased Premises and from and against any and all claims and demands whatsoever which may be asserted against Assignor and/or Assignee by reason of any of the terms and conditions of any Lease.
- If Assignee incurs any such liability, loss, damage or expense, the amount thereof plus interest thereon at the rate per annum equal to seven percent (7%) plus the annual rate of interest published by The Wall Street Journal from time to time as the prime rate shall be paid by Assignor to Assignee immediately upon demand, or at the option of Assignee, Assignee may reimburse itself therefor out of any Rents collected by Assignee.
- 4.3 Nothing contained herein shall operate or be construed to obligate Assignee to perform any of the terms, covenants or conditions contained in any Lease, or to take any action to collect any Rents or other payments or to impose any obligation on Assignee relating to any Lease and/or Leased Premises, including, without limitation, any obligation to construct, complete, operate, sell, lease, retain, repair and/or maintain the Improvements.
- 4.4 Prior to any actual taking of possession of the Leased Premises by Assignee, Assignee shall not have any duty to perior any of Assignor's obligations under any Lease or any duty to construct, complete, operate, maintain, manage, repair, sell, lease and/or retain the Leased Premises, and Assignor covenants that such duties are exclusively Assignor's responsibility.
- 5. Exercise of Remedies. The rights and remedies of Assignee under this Assignment are cumulative and in addition to any other rights and comedies which Assignee shall have under or as a result of any other of the Obligations and may be exercised as often as Assignee deems such exercise to be desirable. Failure of Assignee to avail itse f of any of the terms, covenants and conditions of this Assignment for any period of time, or at any time or times, shall not constitute a waiver of any of its rights hereunder.
- 6. <u>Assignment by Assignee</u>. Assignee shall have the right to assign Assignor's rights, title and interest in the Leased Premises and/or any Lease to any subsequent holder of the mortgage which is one of the Security Documents or to any person acquiring title to the Leased Premises, subject, however, to the provisions of this Assignment. After Assignor shall have been barred and foreclosed of all right, title and interest and equity of redemption in the Leased Premises, no assignee of Assignee's interest in any Lease shall be liable to account to Assignor for any Rents thereafter accruing.
- 7. <u>Termination</u>. Upon payment and satisfaction in full of the Obligations, as evidenced by recorded satisfactions or releases of the recorded Security Documents, and of any sums which may be payable hereunder, or under any present or future agreement between

Assignor and Assignee, this Assignment shall be void and of no effect and, in that event, upon Assignor's request, Assignee agrees to execute and deliver to Assignor instruments evidencing the termination of this Assignment in recordable form.

- 8. <u>No Merger</u>. There shall be no merger of any Lease or the leasehold estate created thereby with the fee estate in the Leased Premises or with any mortgage of said fee by reason of the fact that any Lease or any interest therein may be held by or for the account of any person, firm or corporation which may be or become the mortgagee or owner of said fee estate, unless Assignee shall consent in writing to said merger.
- 9. Notices. Any notice, demand, request or other communication given in connection with this Assignment shall be deemed sufficient if in writing and sent by registered or certified mail, postage prepaid, return receipt requested, addressed to the party to receive such notice at its address first set forth above or as set forth in the Loan Agreement, or at such other address as such party may hereafter designate by notice given in like fashion. Notices shall be deemed given when mailed. Notwithstanding the foregoing, routine communications such as timely payments of Rents may be sent by ordinary first-class mail.

10. Miscellaneous.

- 10.1 This Assignment shall be construed and enforced in accordance with and governed by the laws of the State of Illinois
- 10.2 No amendment, cancellation or discharge of this Assignment shall be valid unless Assignee shall have consented thereto in writing.
- 10.3 In the event there is any conflict between the terms and provisions of any other Security Documents and the terms and provisions of this Assignment, the terms and provisions of this Assignment shall prevail.
- 10.4 The terms, covenants, and conditions contained perein shall inure to the benefit of and bind Assignee and Assignor and their respective successors and assigns.
- 10.5 The term "Assignor" as used herein shall mean all parties, signing this Agreement, and each one of them, and all such parties, their respective successors and assigns, shall be jointly and severally obligated hereunder.
