- 2. On or about January 3, 2006, the Claimant made an oral contract with the Owner. Under this contract, Claimant agreed to develop and construct for the improvement of the premises, for \$7,801,375.00, plus any extras that might be contracted for from time to time payable upon submittal of draws by Claimant to Owner.
- 3. Claimant has submitted eight (8) construction payment applications and Owner has paid Draws 1,2,3 4 and 5 but has not paid Draws 6,7 and 8.
- As of December 1, 2006, Claimant has completed the furnishings and performance of all work, labor and services; Claimant has delivered all material and fixtures required by the contract up to and including Draw 8.
- 5. Owner suspended work on the premises on or about December 1, 2006 in order to raise additional funds and to seek an additional loan to complete the project.
- 6. All of the work, labor, services, material and fixtures was furnished, performed, delivered to and used, in premises' improvement. The last of the work, labor, services, material and fixtures, including any extras, was delivered, performed and furnished, on or about December 1, 2006.
- 7. \$1,482,494.00 is due to Clair ant for the furnishings, performance, and delivery of the work, labor, services, and fixtures, including extras, after allowing the Owner all credits, deductions and setoffs.
- 8. Claimant now claims a Mechanics' Lien on the premises and all improvements described above against all persons interested in the premises for \$1,452,494.00, together with interest, according to the Mechanics' Lien Act.
