## SPECIAL WARRANTY DEED

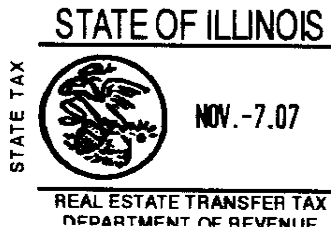
