(Home Equity Conversion Mortgage)

THIS MORTGAGE ("Security Instrument") is given of November 1, 2007. The mortgagor is Earl Brown and Delores Brown, his wife, as joint tenants, whose address is 52.4° S MAY STREET, CHICAGO, ILLINOIS 60621 ("Borrower"). This Security Instrument is given to Jett Financial Services, Inc., which is organized and existing under the laws of the state of California, and whose address is 2555 Camino Del Rio South, Suite 205, San Diego, California 92108 ("Lender"). Borrower has agreed to repay to Lender amounts which Lender is obligated to advance, including future advances, under the terms of a Home Equity Conversion Loan Agreement dated the same date as this Security Instrument ("Loan Agreement"). The agreement to repay is evidenced by Borrower's Note dated the same date as this Security Instrument ("Note"). UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest. Borrower shall pay when due the principal of, and interest on, the debt evidenced by the Note.
- 2. Payment of Property Charges. The amount secured by this Security Instrument shall include all direct payments by conder to Borrower and all other loan advances permitted by this Security Instrument for any purpose. This lien priority shall upply notwithstanding any State constitution, law or regulation, except that this lien priority shall not affect the priority of any liens for any aid State or local governmental unit special assessments or taxes.
- 22. Adjustable Rate Feature. Under the Note, the initial stated interest rate of Four and 97/100 percent (4 970%) which accrues on the unpaid principal balance ("Initial Interest Rate") is subject to change, as described below. When the interest rate changes, the new adjusted interest rate will be applied to the total outstanding principal balance. Each adjustment to the interest rate will be based upon the weekly average yield on United States Treasury Securities adjusted to a constant maturity of one year, ("Index") plus a margin. The Index is published in the Federal Reserve Bulletin and made available by the United States Treasury Department in Statistical Release H.15 (519). If the Index is no longer available, Lender will be required to use any index prescribed by the Department of Housing and Urban Development. The new index will have a historical movement substantially similar to the original index, and the new index and margin will result in an annual percentage rate that is

The Calculated Interest Rate will be adjusted if accessary to comply with the rate limitation(s) described above and will be in effect until the next Change Date. At any change date, if the Calculated Interest Rate equals the Existing Interest Rate, the interest rate will not change.

- 23. Release. Upon payment of all sums secured by this Security Instrument, Lender shall release this Security Instrument without charge to Borrower. Borrower shall pay any recolouson costs.
- 24. Waiver of Homestead. Borrower waives all right of home sead exemption in the Property.
- 25. Riders to this Security Instrument. If one or more r ders are executed by Borrower and recorded together with this Security Instrument, the covenants and agreements of each such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Security Instrument as if the inder(s) were a part of this Security Instrument.
