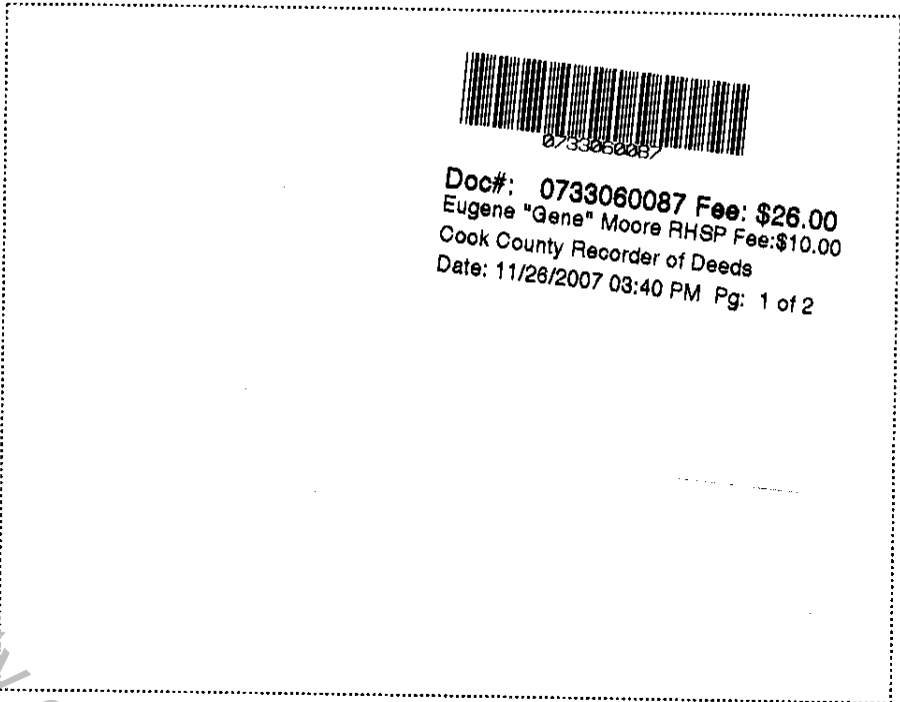


CERTIFICATE OF COMPLIANCE


