THIS PLANNED UNIT DEVELOPMENT RIDER is made this 9th day of November, 2007 incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure the Note to TCF National Bank, 1589 Rand Road N Palatine IL 60067-0000

(the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 115 PRAIRIE PARK DR UNIT #5-412 WHEELING IL 60090-2720

The Property includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and facilities, as described in

(the "Declaration"). The Property is a part of a planned unit development known as PRAINE PARK AT WHEELING CONDO ASSOC

(the "PUP"). The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or na aging the common areas and facilities of the PUD (the "Owners Association") and the uses, benefits and proceeds of Dorrower's interest.

Borrower's obligations under Section 4 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.

What Lender requires as a condition of this waiver can change during the term of this loan.

Borrower shall give Lender prompt notice of any lapse in required hazard insurance coverage provided by the master or blanket policy.

In the event of a distribution of property insurance proceeds in lieu of restoration or repair following a loss to the Property, or to common areas and facilities of the PUD, any promeers payable to Borrower are hereby assigned and shall be paid to Lender. Lender shall apply the proceeds to the sum secured by the Security Instrument, whether or not then due, with any excess, if any, paid to Borrower.

  - (i) the abandonment or termination of the PUD, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the crose of a taking by condemnation or eminent domain;
  - (ii) any amendment to any provision of the "Constituent Documents" if the provision is for the express benefit of Lender:
  - (iii) termination of professional management and assumption of self-management of the Owners
  - (iv) any action which would have the effect of rendering the public liability insurance coverage maintained by the Owners Association unacceptable to Lender.
- E. Remedies. If Borrower does not pay PUD dues and assessments when due, then Lender may pay them.
